The Maternal & Infant Health Dashboard was updated with three additional indicators from the Ohio Pregnancy Assessment Survey (OPAS) Dashboard, including: 1) Pre-Pregnancy E-Cigarette Use; 2) Pre-Pregnancy Smoking; and 3) Postpartum Depression.

United for ALICE launched its newest research, "ALICE in the Crosscurrents: An Update on Financial Hardship in Ohio." In 2022, of the 4,857,452 households in Ohio, 1,897,973 (39%) were below the ALICE (Asset Limited, Income Constrained, Employed) threshold.
